Interest will accrue at the rate of 1.5% per month (18% per annum) on delinquent balances. If a delinquent account is placed in the hands of an attorney or collection agency, the undersigned shall be liable for all costs of collection, including, but not limited to, an attorney fee equal to the greater of 33 1/3% of the monies due to Ultimate Survival Technologies, Inc., or an attorney fee equal to the hourly fee charged by Ultimate Survival Technologies, Inc.'s attorneys multiplied by the hours expended by said attorneys. Attorney fees shall be paid by the undersigned when incurred for consultation, trial or appellate services, whether suit be brought or not. The terms of this agreement shall be governed by the laws of the State of Florida and the parties agree to submit to the jurisdiction of the State of Florida. Venue for settlement of any disputes arising under this Agreement, including litigation, regardless of place of payment, shall be in a forum or Court, as required, of competent jurisdiction in Duval County, Florida, and the undersigned waives any venue rights he may possess and agrees that he shall not contest that Duval County, Florida, is a convenient forum. The undersigned waives all rights to a trial by jury.
